TECHNICAL INFORMATION: This DVD set can be played on computers equipped with a DVD drive, as well as on TVs with a DVD player. The discs are formatted for the NTSC TV standard (North America) and are not available in a PAL TV version. (While some PAL DVD players can play NTSC DVDs, compatibility is not guaranteed.) The DVDs can be viewed on both regular and widescreen TVs. If viewing on a widescreen TV, it is recommended to use the TVs regular (4X3) setting. The discs can be viewed using the TVs widescreen (16X9) setting but by stretching the picture to fill the screen, viewers may find the dogs appear distorted.
